DECREE OF INCORPORATION OF A PUBLIC WATER SUPPLY DISTRICT

Now, on this 22nd day of December, 1964, the same being a regular judicial day of this Court, a hearing was had on the Petition for the formation of a public water supply district filed with the Clerk of this Court the 16th day of September, 1964.

The Court, being fully advised in the premises, finds:

That the Petition in due and proper form, signed by at least five owners of the land within the boundaries of the proposed district and certified by one of the signers of the Petition, has been duly filed in duplicate with the Clerk of this Court, accompanied by a cash deposit of Fifty Dollars.

That due notice of said hearing has been signed by the Clerk of this Court and published in the Post Tribune a daily newspaper of general circulation in this county for twenty successive issues, the last such date of publication being the 4th day of December, 1964, as provided by law.

That no exceptions to the formation of a district have been made.

That it is in the public interest to form such district.

The court orders and decrees:

That said petition is hereby granted and said public water supply district to be hereafter officially known as Public Water Supply District No. One of Cole County, Missouri, is hereby incorporated.

That the boundaries of said district shall be as follows:

Beginning at a point on the southerly bank of the Missouri River where the westerly boundary line of Jefferson Township, Cole County, Missouri intersects with the southern bank of the Missouri River; thence south along the westerly boundary line of Jefferson Township to a point where the section line between Sections 35 and 36 in Township 44 North, Range 13 West intersects with the Moreau River; thence following the meanderings of the Moreau River downstream (which is also the boundary line of Jefferson Township) to a point where the section line between Sections 32 and 33, Township 44 North, Range 12 West intersects the said Moreau River; thence north along the west boundary line of Sections 33, 28, 21 and 16, Township 44 North, Range 12 West, to the northwest corner of Section 16; thence east along the north line of Sections 16, 15, 14 and fractional Section 13, to a point where it intersects with the westerly city limits line of the city of Jefferson (as the city limits are presently established); thence northerly along said city limits line to a point where the northwest corner of the city limits intersects with the Missouri River; thence northerly and westerly along the south bank of the Missouri River to the point of beginning.

ORDER DECLARING DECREE OF INCORPORATION OF PUBLIC WATER
SUPPLY DISTRICT TO BE FINAL AND CONCLUSIVE

Now on this 18th day of January, 1965, the Court finds that an election was duly held on the 15th day of January, 1965, upon the proposition of incorporation of Public Water Supply District No. One of Cole County, Missouri, and the returns have been duly certified to the Court by the Judges and Clerks of said election.

Upon canvassing such returns, the Court finds that 333 electors voted for the proposition and 17 electors voted against the proposition and that the proposition submitted at said election has been assented to by a majority of two-thirds of the qualified voters of said district voting on such proposition.

It is therefore ordered and declared that the Decree of Incorporation of said district entered by this Court is final and conclusive.
