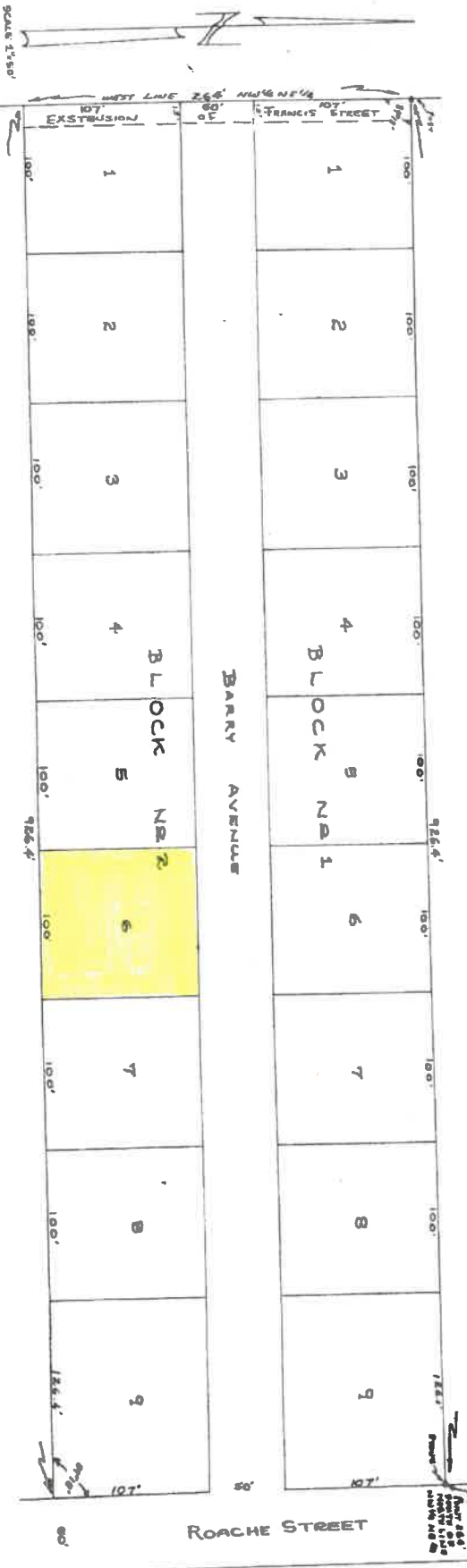


# "BARRY ADDITION" TO THE CITY OF CALIFORNIA, MO.

THIS IS TO CERTIFY THAT DEXTER SLAGLE, SURVEYOR, BEING THE MOUTH OF AUGUST 1957, BY ORDER OF THE BOARD UNDER APPEALS AS JUDGE ON THIS PLAT, MADE A SURVEY AND SUBDIVISION OF THIS FOLLOWING DESCRIBED TRACT OF LAND, COMMENCING AT A POINT 264 FEET SOUTH OF THE NORTH LINE OF THE NORTH WEST QUARTER (NW1/4) OF THE NORTHEAST QUARTER (NE1/4) OF SECTION 35, TOWNSHIP 45 NORTH, RANGE 18 WEST, SAID POINT BEING ON THE WEST LINE OF ROACH STREET IN THE CITY OF CALIFORNIA, MISSOURI, AND RUN - LINE THENCE SOUTH 264 FEET ALONG THE WEST LINE OF ROACH STREET, THENCE WEST 916.4 FEET TO THE WEST LINE OF SAID QUARTER, QUARTER, THENCE NORTH 264 FEET, THENCE EAST TO THE POINT OF BEGINNING.
